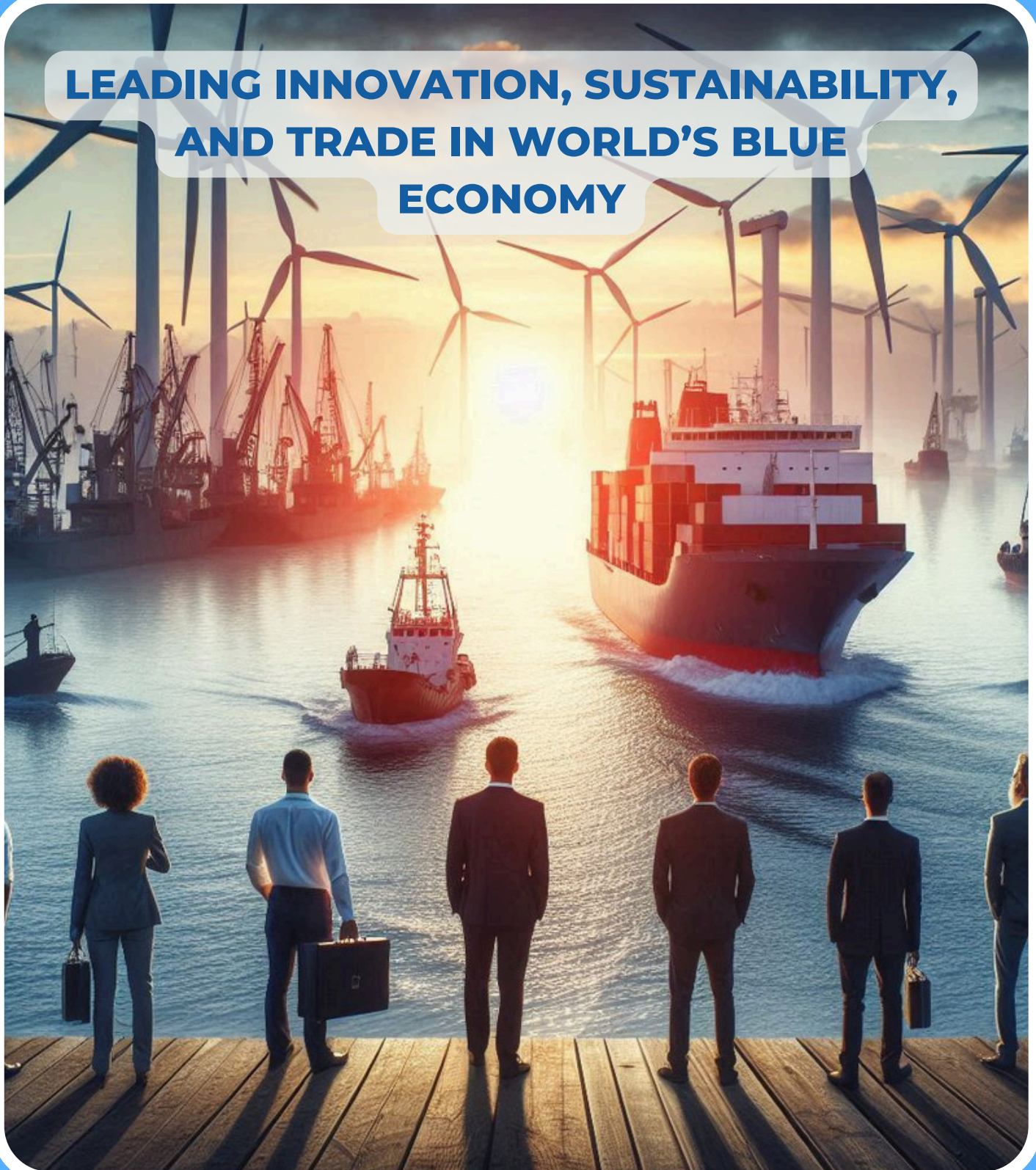

## *Marine Conservation and Coastal Ecosystem Protection*

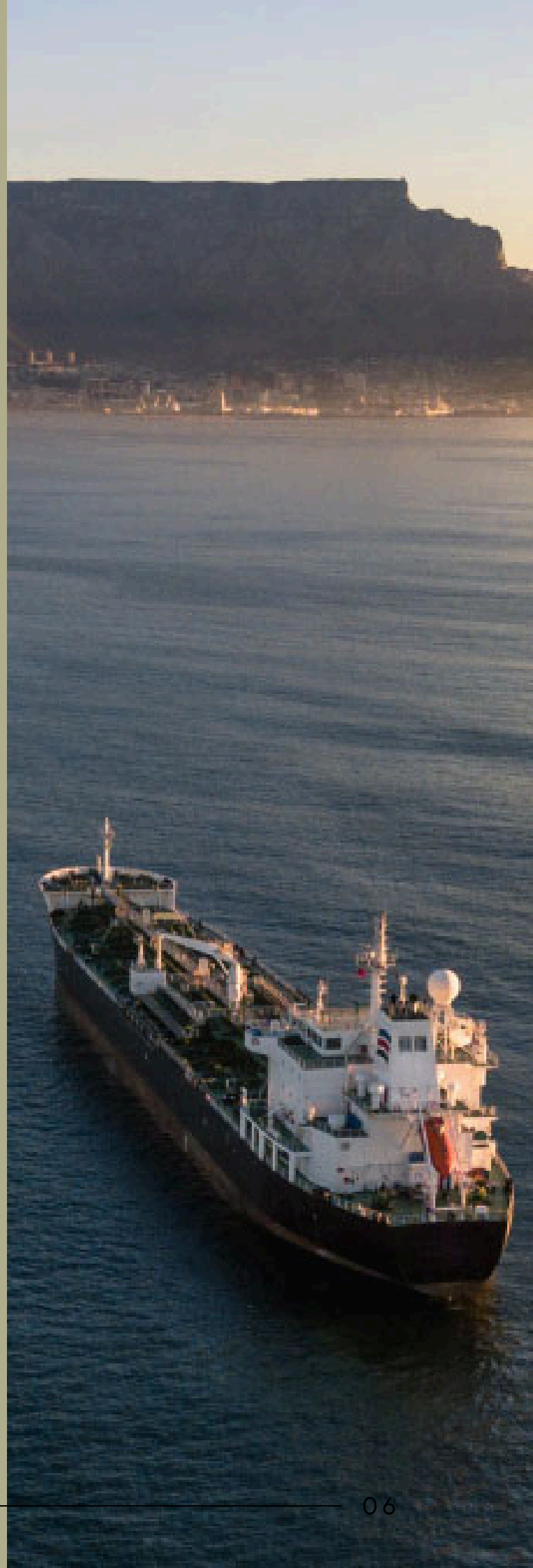
